

LaPORTE COUNTY ORDINANCE NUMBER 97- 17

**AN ORDINANCE DELETING SPEED LIMITS SUBSEQUENTLY
INCORPORATED INTO LaPORTE COUNTY ORDINANCE
1996-21 SETTING SPEED LIMITS IN SUBDIVISIONS**

**IT HAS COME TO THE ATTENTION OF THE
LaPORTE COUNTY BOARD OF COMMISSIONERS THAT:**

WHEREAS, on December 9, 1996 the Board of Commissioners enacted Ordinance 1996-21, setting speed limits in subdivisions;

WHEREAS, certain streets have been previously designated with established speed limits;
and

WHEREAS, the Subdivision Speed Limits Ordinance incorporates these streets.

**NOW, THEREFORE, BE IT ORDAINED BY THE
BOARD OF COMMISSIONERS OF LaPORTE COUNTY, INDIANA THAT:**

1. County Code Chapter 7 Article 1 (Speed Limit Designations) Section 7-3 Paragraph 8, setting a twenty (20) Mile per Hour speed limit on Kowal Drive in Beacan Hill Subdivision be, and it hereby is, deleted and said Paragraph shall be reserved for future use.

2. Chapter 7 Article 1 (Speed Limit Designations) Section 7-3 Paragraph 15, setting a twenty (20) Mile per Hour speed limit in the Subdivision of Decker Woods in Center Township be, and it hereby is, deleted and reserved for future use.

3. Chapter 7 Article 1 (Speed Limit Designations) Section 7-5 Paragraphs 45, 46, 47 and 48 setting a thirty (30) Mile per Hour speed limit in Indian Trail Subdivision, Tiffany Woods Subdivision, Timber Ridge Subdivision and North View Subdivision be, and they hereby are, deleted and reserved for future use.


4. Chapter 7 Article 1 (Speed Limit Designations) Section 7-6 Paragraph 11, setting a thirty-five (35) Mile per Hour speed limit on Jongkind Boulevard between Johnson Road and 250 North be, and it hereby is, deleted and reserved for future use.


In all other respects, LaPorte County Code Chapter 7 is confirmed reserving to the Board of Commissioners the right to further amend or revoke the same and this amendment thereto.

This Ordinance shall be in full force and effect beginning the 2nd day of September, 1997, and after its enactment and publication as prescribed by law.
