

ORDINANCE NO. 97-28

**AN ORDINANCE TO VACATE A PORTION OF LILY LANE
HUDSON TOWNSHIP, LAPORTE COUNTY, INDIANA**

WHEREAS, Michael McCormick and Tammy Eshman have filed a petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of LaPorte County, Indiana, asking that a portion of Lily Lane in Hudson Township, LaPorte County, Indiana, be vacated, which portion is more particularly described as follows:

That portion of Lily Lane within the plat of Hudson Lake Beach Subdivision beginning at the northeast corner of Lot 5799, then east 147' to the northwest corner of Lot 5805, then north 30' to the north border of Lily Lane, then west 147' to the southeast corner of Lot 6110, then 30' feet south to the place of beginning.

and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on September 23, 1997; and,

WHEREAS, the Petitioners gave notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed by I.C. 5-3-1-1 et seq; and,

WHEREAS, the Petitioners provided notice of the filing of this petition and of the hearing thereon by certified mail return receipt requested upon all adjacent and interested property owners who own property abutting Lily Lane; and,

WHEREAS, the Board of County Commissioners, as the legislative body of LaPorte County, Indiana, has now conducted the public hearing on the petition to vacate and has determined that a portion of Lily Lane, described above, should be vacated, all as permitted by I.C. 36-7-3-12;

NOW THEREFORE,

Section 1. BE IT, AND IT IS, HEREBY ORDAINED by the Board of County Commissioners of LaPorte County, Indiana, that the following described real estate situated in LaPorte County, State of Indiana, to-wit:

That portion of Lily Lane within the plat of Hudson Lake Beach Subdivision beginning at the northeast corner of Lot 5799, then east 147' to the northwest corner of Lot 5805, then north 30' to the north border of Lily Lane, then west 147' to the southeast corner of Lot 6110, then 30' feet south to the place of beginning.

be, and the same is, hereby vacated as a public way.

Section 2. The Clerk of the Board of County Commissioners of LaPorte County, Indiana, shall furnish a copy of this vacation ordinance to the LaPorte County Recorder in order that the same be placed of record in the records of the LaPorte County Recorder's Office, and shall also furnish a copy to the LaPorte County Auditor.
