ORDINANCE NO. 99-5

AN ORDINANCE TO VACATE AN ALLEY
IN ROLLING PRAIRIE
KANKAKEE TOWNSHIP, LA PORTE COUNTY, INDIANA

WHEREAS the Estate of Mabel Turak, as fee owner, has filed a petition, pursuant to IC 36-7-3-12, with the Board of County Commissioners of La Porte County, Indiana, asking that the unimproved alley separating Lots 42, 43 and 44 from Lots 45, 46 and 47 in W. J. Walker's First Addition to the Town of Portland, now Rolling Prairie, according to the map or plat of said Walker's Addition, as recorded in the Office of the La Porte County Recorder, be vacated, and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on the 11th day of May, 1999, and,

WHEREAS, the Clerk of the Board of County Commissioners of La Porte County, Indiana, gave notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed by IC 5-3-1-1 et seq, and,

WHEREAS, all contiguous landowners have been given notice of the filing of this petition, and,

WHEREAS, the Board of County Commissioners, as the legislative body of La Porte County, Indiana, has now conducted the public hearing on the petition to vacate and has determined that the alley, described above should be vacated, all as permitted by IC 36-7-3-12.

NOW, THEREFORE,

Section 1. BE IT, AND IT IS, HEREBY ORDAINED by the Board of County Commissioners of La Porte County, Indiana, that the public way, twenty (20') feet in width, which has constituted an alley separating Lots 42, 43, and 44 from Lots 45, 46 and 47 between Walnut Street and Plain Street in W. J. Walker's First Addition to the Town of Portland, now






