AN ORDINANCE TO VACATE A CERTAIN TWELVE FOOT WIDE ALLEY EXISTING BETWEEN LOT 6 AND LOT 7 IN BLOCK 5 AS SHOWN ON THE RECORDED PLAT OF HANNA RECORDED IN PLAT BOOK 1, PAGE 180 IN THE OFFICE OF THE RECORDER OF LA PORTE COUNTY, INDIANA

WHEREAS, Maupin, Inc., has filed a Petition for vacation of a certain twelve (12) foot wide alley way existing between Lot 6 and Lot 7 in Block 5 as shown on the recorded Plat of Hanna recorded in Plat Book 1, page 180, in the office of the Recorder of La Porte County, Indiana; and,
