ORDINANCE NO. 2001 - 25

**AN ORDINANCE CREATING NEW COUNTY COMMISSION DISTRICTS  
IN THE COUNTY OF LAPORTE, STATE OF INDIANA**

**WHEREAS**, the LaPorte County Board of Commissioners is required to divide the County into three (3) county commission districts by December 31, 2001 under the provisions of I.C. § 36-2-2-4,

**NOW THEREFORE BE IT ORDAINED** by the LaPorte County Board of Commissioners, LaPorte County, Indiana that the following territory within said County is hereby divided into county commission districts. The districts contain the following precincts, defined, to-wit:

**DISTRICT 1:**

Hydrology- Lake Michigan (NV), Long Beach Precinct, Michiana Shores, Michigan Precinct 2, Michigan City Ward 1 Precinct 1, Michigan City Ward 1 Precinct 2, Michigan City Ward 1 Precinct 3, Michigan City Ward 2 Precinct 1, Michigan City Ward 2 Precinct 2, Michigan City Ward 2 Precinct 3, Michigan City Ward 2 Precinct 4, Michigan City Ward 3 Precinct 1, Michigan City Ward 3 Precinct 2, Ward 3 Precinct 2 Coolspring, Michigan City Ward 4 Precinct 1, Michigan City Ward 4 Precinct 2, Michigan City Ward 4 Precinct 3, Michigan City Ward 4 Precinct 4, Michigan City Ward 5 Precinct 1, Michigan City Ward 5 Precinct 2, Michigan City Ward 5 Precinct 3, Michigan City Ward 5 Precinct 4, Michigan City Ward 6 Precinct 1, Michigan City Ward 6 Precinct 2, Michigan City Ward 6 Precinct 3A (Michigan), Michigan City Ward 6 Precinct 3B (Coolspring), and Springfield Precinct 3.




BE IT FURTHER ORDAINED THAT:


1. All other ordinances in conflict herewith are expressly repealed

3. Commissioners elected at the general elections of 2000 for full four-year terms shall continue to hold office as residents of the new districts in which their legal residence is located until the terms for which they were elected have expired.
4. This ordinance shall be in full force and effect upon passage, approval and publication by the Board of Commissioners of LaPorte County.



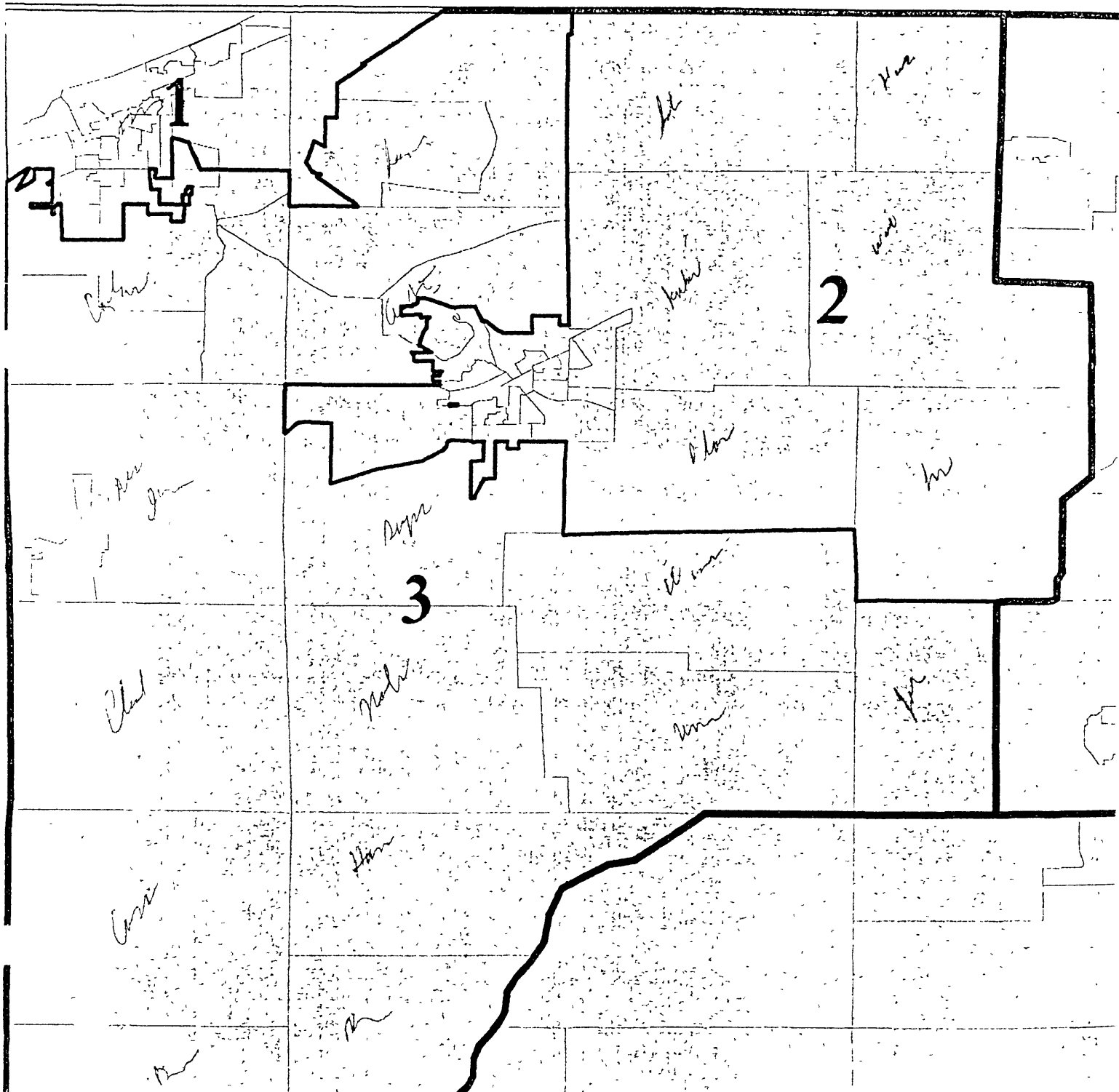

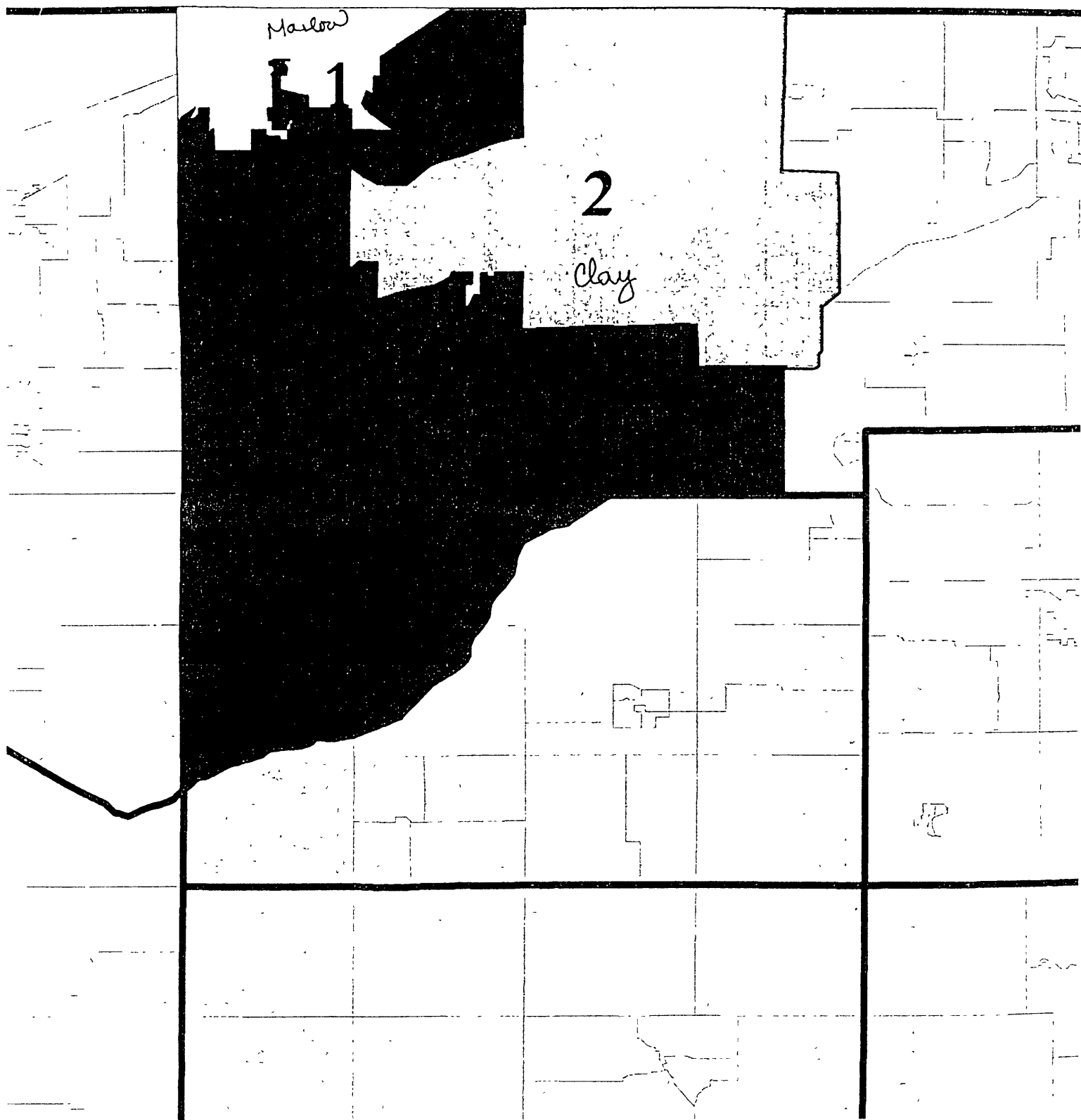
