WHEREAS, LaPorte County has no specific use for such property and the same would be deemed excess, and;

WHEREAS, each owner of such delinquent parcel involved has been notified of the intent and request of Michiana Shores for the transfer and have voiced no objection thereto, and,


WHEREAS, LaPorte County has no interest in such parcels


NOW THEREFORE, be it resolved by the Board of Commissioners of LaPorte County that.

steps to publish notice of this matter for public hearing



