AN ORDINANCE PROVIDING FOR THE VACATION OF A ONE HUNDRED FEET PORTION OF A PUBLIC STREET THIRTY FEET WIDE SHOWN AS WALNUT LANE.

WHEREAS, JOHN HALL has filed a petition with the LaPorte County Commissioners under the provisions of Indiana Code 36-7-3-12 and 36-7-3-13 for the vacation of a portion of Walnut Lane.

WHEREAS, notice of a hearing before the LaPorte County Commissioners has been published in the LaPorte Herald Argus in its issue of April 23, 2003, publication being at least ten (10) days before the date of this hearing; and

WHEREAS, it is desirable and in the best interests of the LaPorte County, Indiana, to vacate said portion of Walnut Lane (a) because petitioner owns all contiguous property, (b) that the vacation of said portion of Walnut Lane will not materially damage the adjoining property, and will relieve the County of LaPorte of future responsibility for maintaining the same, and (c) will add the property vacated to the tax rolls of the County of LaPorte, Indiana

NOW THEREFORE, BE IT ORDAINED BY THE LAPORTE COUNTY COMMISSIONERS of the County of LaPorte, Indiana, as follows

SECTION 1.

That the one hundred (100) feet portion of Walnut Lane, adjacent to Lots 4997 and 4998 of Hudson Lake Beach, LaPorte County, Indiana is hereby vacated, and in accordance with the law of the State of Indiana, the fee simple title to the vacated portion of Walnut Lane reverts to the adjoining property owner, i e JOHN HALL

SECTION 2.

This Ordinance shall be in full force and effect from and after its approval and passage by the LaPorte County Commissioners of LaPorte County, Indiana, as required by law.


