Wells Fargo Representative/ Direct Deposit

Peter Essig, I was asked to come and discuss the proposal that we presented to the LaPorte County Auditor on ACH which would facilitate direct deposit. ACH stands for automatic clearance housing basically it is an electronic way to transfer funds and allows you to have direct deposit for your employees. Why this is a benefit to the county as far as an employer is because it can be integrated into the existing payroll software that you use, once the money is transferred it is available to the

employee right away. The funds can be sent to any legal bank or any credit union; we offer services for any employee who does not have an account.

Mr. Hager, how long will this take to be set up?

Mr. Cudney, the deposit process will be immediately into the bank account so the funds are available immediately.

Mr. Hager, how long does it take to set this program up?

Mr. Essig, the deposit process can be set up within a one week period from the time that you decide this is what you want to do.

Mr. Harmon, being that this is going to be a mandatory and some don't have accounts how are you going to handle that issue.

Mr. Essig, we have a specific account that can help with that and receipt with that and everyone qualifies for it and they can just come to the bank and get it. Now it is also available you do not have to use Wells Fargo it will go to any bank or credit union.

Mr. Hager, how long Mrs. Shuter wills it be get everyone educated in the county?

Mrs. Shuter, I am anticipating it is going to take a little while, probable a month.

Mrs. Huston, made a motion to allow Mrs. Shuter to move forward on the mandatory direct deposit with Wells Fargo Bank, second by Mr. Hager. Motion carried with a roll-call vote 3-0.

Waste Transfer Station:

Mr. Harmon, I am going to ask that this be put under "New Business" in reference to the Waste Transfer Station, it there are no objections from the board, hearing no objection. I want to give a statement first, then a resolution that I want the board to consider passing. I think that this is a wise choice for the commissioners to take as there has been opposition to this transfer station going into the location that we are talking about at this time. As long at it goes into an industrial park in a proper location we have no problem with that it does not belong in a residential area.

Mr. Harmon, the appeal process is 15 days after it is filed are we passed that to get involved with this.

Mr. Friedman there is a petition been filed by Porter County we will seek to determine to see if we can intervene there is a process under Indiana Law that says permits for potential intervention there is a prehearing conference set for January 9th and a state hearing for January 19th.

Mr. Cudney: the January 9th meeting has been changed to January 10th.
