LAPORTE COUNTY BOARD OF COMMISSIONERS

Tuesday, November 21, 2006

The LaPorte County Board of Commissioners met in regular session on Tuesday, November 21, 2006 at 10:00 a.m. in the LaPorte County Complex Meeting Room #3.

Present at the meeting were Commission President Marlow Harmon and Commission Member William Hager. Also present were LaPorte County Auditor Teresa Shuter, LaPorte County Attorney Robert Szilagyi and Executive Secretary Linda Arnett. Commission Vice President Barbara Huston was absent.

MEETING CALLED TO ORDER

Commission President Marlow Harmon called the meeting to order at 10:00 a.m...

PLEDGE OF ALLEGIANCE

Commission Member William Hager led the Pledge of Allegiance.

APPROVAL OF AGENDA

Mr. Harmon, under "New Business add section "A" Opening Bids Al Ott, Maintenance Supervisor and under section "B" amendment to Policy Manual in reference to PTO Time.

Mr. Hager, made a motion to approve the agenda as amended, second by Mr. Harmon. Motion carried with a voice vote 2-0.

Robert Young, LaPorte County Highway Superintendent/ Employee Health Insurance Additional Appropriation of \$174,000.00

Mr. Young, this goes back to 2003 thru 2005 we never raised our health insurance in the budget.

Mrs. Shuter, we need an additional appropriation to cover their health insurance benefits due to a short fall this year.

Mr. Hager, made a motion to approve the additional appropriation in the amount of \$174,000.00 to be taken out of the MVH Fund, second by Mr. Harmon. Motion carried with a roll-call vote 2-0.

Attorney Szilagyi, we have three bids in as follows: Larson-Danielson is for \$449,728.00, Tonn & Blank for \$499,632.00 and L.I. Combs & Sons, Inc. for \$570,000.00.
