LAPORTE COUNTY BOARD OF COMMISSIONERS TUESDAY, DECEMBER 4, 2007

The LaPorte County Board of Commissioners met in regular session on Tuesday, December 4, 2007 at 6:00 p.m. in the LaPorte County Complex Meeting Room #3.

Present at the meeting were Commission President Barbara Huston, Commission Vice President William Hager and Commission Member Michael Bohacek. Also present were LaPorte County Auditor Teresa Shuter, LaPorte County Attorney Robert Szilagyi and Executive Secretary Linda Arnett.

PLEDGE OF ALLEGIANCE

Mayor Morris led the Pledge of Allegiance.

APPROVAL OF AGENDA

Mr. Bohacek made a motion to accept the agenda as presented, second by Mr. Hager. Motion carried with a voice vote 3-0.

APPROVAL OF MINUTES

Mr. Bohacek made a motion to approve the minutes of October 16, 2007 & November 13, 2007, second by Mr. Hager. Motion carried with a voice vote 3-0.

WEEKLY REPORTS

Commissioners review and sign the weekly reports during the meeting.

CLAIMS

Mr. Bohacek made a motion to approve Payroll Ending- December 14, 2007 & December 28, 2007, second by Mr. Hager. Motion carried with a roll-call vote 3-0.

Mr. Hager made a motion to approve Miscellaneous Claims in the amount of \$607,346.53, second by Mr. Bohacek. Motion carried with a roll-call vote 3-0.

Mr. Bohacek made a motion to approve the settlement in the amount of \$9,826.84, second by Mr. Hager. Motion carried with a roll-call vote 3-0.

The other the \$829,983.36 of the Major Moves is from the, every County in the State got money from the Major Moves based on road miles and population and this would go into the MVH fund and then the \$170,061.61 would be out of the Departments unappropriated balance and would go for paving of paving bills and limestone.

Mr. Hager made a motion to approve on second and final reading by title only, second by Mr. Bohacek. Motion carried with a voice vote 3-0.

Mrs. Huston this will be known as Ordinance #2007-23.

Attorney Robert Szilagyi/ Ordinance to Amend Cell Tower Fees

Mr. Szilagyi this is an ordinance presented by the plan commission to raise the fees for Cell Towers and this is the second reading on this ordinance.

Mr. Bohacek made a motion to read the ordinance on second and final reading by title only.

ORDINANCE TO AMEND CELL TOWER FEES

Mr. Hager made a motion to approve on second and final reading, second by Mr. Bohacek. Motion carried with a voice vote 3-0.

Mrs. Huston this will be known as Ordinance #2007-24.

Attorney Robert Szilagyi/ Ordinance to Amend Chapter 8, Section 8-22 of the LaPorte County Zoning Ordinance Regarding Cell Towers

Mr. Szilagyi, this is the second reading and has the recommendation of the Plan Commission.

Mr. Hager made a motion to approve on second and final reading.

ORDINANCE TO AMEND CHAPTER 8; SECTION 8-22 OF THE LAPORTE COUNTY ZONING ORDINANCE REGARDING CELL TOWERS

Mr. Hager made a motion to approve on second and final reading by title only, second by Mr. Bohacek. Motion carried with a voice vote 3-0.

Mrs. Huston this will be known as Ordinance #2007-25.

Rick McVay, LaPorte County Highway Engineer/ Receive RFP's on Johnson Road Project

Mr. McVay, we are here to receive the RFP'S and the other thing we need to do tonight is to appoint a committee to review the RFP'S and come up with a recommendation. What the state does is they recommend a five (5) person committee but it is up to you.

Mr. Hager made a motion to approve the three commissioners, Rick McVay and Mr. Bob Young on the committee to review these and make the recommendation. Motion carried with a voice vote 3-0.

Mr. Bohacek how long will it take you to sort thru them.

Mr. McVay I could get that done this week and make sure everyone meets the qualifications, I have everything the state needs filled out.

Mr. Hager if all of them pass you could give us the information and we could review them individually and that way we would not be in violation of the open door law.

Mr. Szilagyi, opens the RFP's as follows; American Structure Point, Inc., Butler, Fairman and Seufert, K & S Engineers, Inc., Ken Herceg and Associates, Inc., Lawson Fisher Associates, P.C., RQAW CONSULTING Engineers & Architects, Schneider Corporation, The Troyer Group and United Consulting.

Mr. Hager made a motion to turn them over to the Highway Engineer, Rick McVay for his review, second by Mr. Bohacek. Motion carried with a voice vote 3-0.

Attorney Christopher L. Willoughby/ Horizon Development, Inc. Rezone From Agricultural to R-1 Residential second and final reading

Christopher L. Willoughby, we are asking the board to follow up the Rezone from Agricultural to R-1 Residential on second reading.

Mr. Hager, made a motion to pass on second and final reading by title only, second by Mr. Bohacek.

Mrs. Huston reads the Ordinance on second and final reading by title only as follows;

AN ORDINANCE TO AMEND ARTICLE IV SECTION 8-6 OF THE LAPORTE COUNTY MASTER PLAN AND THE ZONE MAP WHICH IS A PART THEREOF IN ORDER TO REZONE AND RECLASSIFY A PARCEL OF REAL ESTATE IN THE COUNTY OF LAPORTE

Motion carried with a voice vote 3-0.

Mrs. Huston this will be known as Ordinance #2007-26.

NEW BUSINESS

Kenneth Layton, LaPorte County Treasurer/ Ordinance

Mr. Layton, I asked Mr. Szilagyi to prepare an ordinance to be brought before the commissioners tonight for their consideration and what it is in reference to the new house bill that was passed two weeks ago 10-10. The language has changed as far as the state statue pertaining to the refund check that the State of Indiana wants to give out to the people. The old ordinance said that we had to mandate to check personnel property and real property to see if there was any delinquency and if there were we would take them out of the refund and apply it to what was delinquent. The new law that was passed two weeks ago eliminated that and allowed local government to pass their own ordinance if they wanted to do it and I am asking the commissioners to entertain

the idea of introducing this ordinance that mandates the Treasurers Office to look for delinquent taxes prior to sending out any rebates or refund checks and apply the refund checks to the delinquent taxes first.

Mr. Bohacek if this ordinance is passed and we have a property owner who owns multiple parcels but is delinquent on one parcel but not the others, will the refunds from the other parcels that are current then be withheld to offset any other parcel.

- Mr. Layton there will only be one parcel that is allowed a refund, the other will not have a refund.
- Mr. Hager how many are in the county?
- Mr. Layton, thirty thousand
- Mr. Hager how many are delinquent?
- Mr. Layton there are several thousand, we have ten years of delinquent judgments in the Clerks Office that we will have to research.
- Mr. Hager, made a motion to approve by title only, second by Mr. Bohacek.
- Mrs. Huston reads the ordinance by title only as follows;

ORDINANCE TO RETAIN AND APPLY TAXES BASED TO DELIQUENT TAXES

- Mr. Hager made a motion to approve, second by Mr. Bohacek. Motion carried with a voice vote 3-0.
- Mr. Hager made a motion to suspend the rules and pass this ordinance on second and final reading by title only.
- Mrs. Huston reads the ordinance for second and final reading by title only as follows;

ORDINANCE TO RETAIN AND APPLY TAXES BASED TO DELIQUENT TAXES

- Mr. Bohacek seconded the motion to approve. Motion carried with a voice vote 3-0.
- Mrs. Huston, this will be known as Ordinance #2007-27

Attorney Robert Szilagyi, Notice to Bid County Farm Land

- Mr. Szilagyi, you have the public notice this is the farmland by the County Home its 125 acres.
- Mr. Hager made a motion to pass this, I think it should be bid out, second by Mr. Bohacek. Motion carried with a voice vote 3-0.

Allen Ott, LaPorte County Stationary Engineer/ Open Proposals

- Mr. Hager made a motion to close the bids, second by Mr. Bohacek. Motion carried with a voice vote 3-0.
- Mr. Szilagyi opens the bids as follows;
