ORDINANCE TO ESTABLISH  
COPY FEES


WHEREAS, there is a need to establish copy fees for the various offices and departments within the LaPorte County government.


NOW THEREFORE, be it ordained and established by the LaPorte County Board of Commissioners that:

1. The following fees are established for copying in County offices:
  - a. Regular copy fees - 15¢ per page.
  - b. Faxes - 15¢ per page.
  - c. Real estate data disc - \$75.00 (\$60.00) if disc is provided.
  - d. Individual real estate data sheets shall be at 50¢ per page.
  - e. Mass storage device - \$60.00.
2. All funds collected by any department or office regarding such fees shall be deposited with the County Auditor no less than weekly for the same to be deposited in the County General Fund.
3. Any other ordinance or parts of ordinances in conflict herein are hereby rescinded.
4. This ordinance shall be in full force and effect immediately upon its passage.

ORDINANCE TO ESTABLISH  
COPY FEES

WHEREAS, there is a need to establish copy fees for the various offices and departments within the LaPorte County government.

NOW THEREFORE, be it ordained and established by the LaPorte County Board of Commissioners that:

1. The following fees are established for copying in County offices:
  - a. Regular copy fees - 15¢ per page.
  - b. Faxes - 15¢ per page.
  - c. Real estate data disc - \$75.00 (\$60.00) if disc is ~~framed~~ *provided*
  - d. Individual real estate data sheets shall be at 50¢ per page.  
*Mass storage device - \$60.00 -*
2. All funds collected by any department or office regarding such fees shall be deposited with the County Auditor no less than weekly for the same to be deposited in the County General Fund.
3. Any other ordinance or parts of ordinances in conflict herein are hereby rescinded.
4. This ordinance shall be in full force and effect immediately upon its passage.
