

ORDINANCE NO. 2011-13

**AN ORDINANCE TO ESTABLISH AND REDEFINING ELECTION PRECINCTS
IN THE COUNTY OF LAPORTE, STATE OF INDIANA**

WHEREAS, state law mandated the LaPorte County Board of Commissioners to realign Precincts to comply with new boundary and maximum voter requirements, and

WHEREAS, the LaPorte County Board of Commissioners submitted to the State of Indiana Election Board an order bringing all precincts into compliance with the law, and

WHEREAS, the State of Indiana Election Board has approved these precinct changes, as Modified, which became effective immediately; and

WHEREAS, all previous ordinances describing precinct boundary lines need to be amended to Reflect the changes in the affected precincts;

NOW THEREFORE BE IT ORDAINED by the LaPorte County Board of Commissioners, LaPorte County, Indiana that all ordinances relating to precinct boundaries in LaPorte County Are hereby amended, as follows:

SPRINGFIELD 1

Commencing at the intersection of the centerline of County Road 500 West and the centerline of County Road 800 North for the point of beginning Thence East along the centerline of County Road 800 North to the centerline of State Road 39 Thence South along the centerline of State Road 39 to the centerline of US Highway 20 Thence west along the centerline of US Highway 20 to the centerline of County Road 400 West Thence south along the centerline of County Road 400 West to south line of Springfield Township Thence west along the south line of Springfield Township to the centerline of US Highway 35 Thence northwesterly along the centerline of US Highway 35 to the easterly right of way line of Interstate 94 Thence northerly along the easterly right of way line of Interstate 94 to the centerline of Warnke Road Thence southeasterly along the centerline of Warnke Road to the centerline of County Road 525 East Thence north along the centerline of County Road 525 East to the centerline of County Road 750 North Thence east along the centerline of County Road 750 North to the centerline of County Road 500 West Thence north along the centerline of County Road 500 West to the point of beginning

SPRINGFIELD 2

Commencing at the easterly right of way line of Interstate 94 and the north line of Springfield Township for the point of beginning Thence east along the north line of Springfield Township to the east line of Springfield Township Thence south along the east line of Springfield Township to the south line of Springfield Township Thence west along the south line of Springfield Township to the centerline of County Road 400 West

Thence north along the centerline of County Road 400 West to the centerline of US Highway 20 Thence easterly along the centerline of US Highway 20 to centerline of State Road 39 Thence north along the centerline of State Road 39 to the centerline of County Road 800 North Thence west along the centerline of County Road 300 North to the centerline of County Road 500 West Thence north along the centerline of County Road 500 West to easterly right of way line of Interstate 94 Thence northerly along the easterly right of way line of Interstate 94 to the point of beginning

SPRINGFIELD 3

Commencing at the intersection of the north line of Springfield Township and the corporation limits of the town of Michiana Shores Thence east along the north line of Springfield Township to the easterly right of way line of Interstate 94 Thence southerly along the easterly right of way line of Interstate 94 to centerline of County Road 500 West Thence South along the centerline of County Road 500 West to the centerline of County Road 750 North Thence west along the centerline of County Road 750 North to the centerline of County Road 525 West Thence south along the centerline of County Road 525 West to centerline of Warnke Road Thence northwesterly along the centerline Of Warnke Road to the easterly right of way line of Interstate 94 Thence southerly along the easterly right of way line of Interstate 94 to the centerline of US Highway 20 Thence west along the centerline of US Highway 20 to the centerline of US Highway 35 Thence southeasterly along the centerline of US Highway 35 to the south line of Springfield Township Thence west along the south line of Springfield Township to the west line of Springfield Township Thence north along the west line of Springfield Township to the southerly corporation limits of the town of Michiana Shores Thence northeast along the south line of the corporation limits of the town of Michiana Shores to the east corporation limits of the town of Michiana Shores Thence northerly along the east corporation limits of the town of Michiana Shores to the point of beginning

WASHINGTON TOWNSHIP

All of Washington Township except the following:

Commencing at the northwest corner of the corporation limits of the town of Kingsbury Thence east along the north corporation limits of the town of Kingsbury and following the corporation limits of the town of Kingsbury to its intersection with County Road 500 South Thence west along the centerline of County Road 500 South approximately 543 feet Thence South to the southerly right of way line of the Grand Trunk Railroad Thence southwesterly along the southerly right of way line of the Grand Trunk Railroad to a point approximately 340 feet northeast of the centerline of US Highway 35 Thence south approximately 330 feet Thence east to the northerly right of way line of the Grand Trunk Railroad Thence southwesterly along the northerly right of way line of the Grand Trunk Railroad to the centerline of Main Street Thence southerly along the centerline of Main Street to a point approximately 100 feet north of the centerline of US Highway 6 Thence west approximately 435 feet Thence northeasterly approximately 4738 feet to a point approximately 433 feet west of the centerline of Main Street Thence east to the centerline of Main Street Thence northerly along the centerline of Main Street and the centerline of Main Street extended to the point of beginning.

DUNELAND BEACH

Commencing at the intersection of the centerline of Moore Road and the centerline of Lake Shore Drive for the point of beginning Thence northeasterly along the centerline of Lake Shore Drive to the west corporation limits of the town of Michiana Shores Thence south along the west corporation limits of the town of Michiana Shores to north corporation limits of the city of Michigan City Thence westerly along the north corporation limits of the city of Michigan City to the centerline of Moore Road Thence northwesterly along the centerline of Moore Road to the point of beginning.

KINGSBURY

Commencing at the northwest corner of the corporation limits of the town of Kingsbury Thence east along the north corporation limits of the town of Kingsbury and following the corporation limits of the town of Kingsbury to its intersection with County Road 500 South Thence west along the centerline of County Road 500 South approximately 543 feet Thence South to the southerly right of way line of the Grand Trunk Railroad Thence southwesterly along the southerly right of way line of the Grand Trunk Railroad to a point approximately 340 feet northeast of the centerline of US Highway 35 Thence south approximately 330 feet Thence east to the northerly right of way line of the Grand Trunk Railroad Thence southwesterly along the northerly right of way line of the Grand Trunk Railroad to the centerline of Main Street Thence southerly along the centerline of Main Street to a point approximately 100 feet north of the Commencing at the northwest corner of the corporation limits of the town of Kingsbury centerline of US Highway 6 Thence west approximately 435 feet Thence northeasterly approximately 4738 feet to a point approximately 433 feet west of the centerline of Main Street Thence east to the centerline of Main Street Thence northerly along the centerline of Main Street and the centerline of Main Street extended to the point of beginning

All that lies within the corporation limits of the town of Kingsford Heights.

DEWEY TOWNSHIP

All of Dewey Township except the following
Commencing at intersection of US Highway 421 and the north corporation limits of the town of LaCrosse Thence east along the north corporation limits of the town of LaCrosse and following the corporation limits to the centerline of Oneida Street Thence east along the centerline of Oneida Street extended approximately 800 feet Thence south approximately 171 feet Thence west 111 feet Thence south approximately 100 feet Thence west approximately 84 feet Thence north approximately 100 feet Thence west approximately 80 feet Thence south approximately 100 feet Thence west to the east corporation limits of the town of LaCrosse Thence south along the east corporation limits of the town of LaCrosse and following the corporation limits to the point of beginning

All that lies within the corporation limits of the town of Long Beach

MICHIANA SHORES 2

Commencing at the intersection of the Indiana State line and the centerline of El Portal Drive for the point of beginning Thence east along the north Indiana state line to the centerline of Brookside Drive Thence southwesterly along the centerline of Brookside Drive to the east corporation limits of the town of Michiana Shores Thence south along the east corporation line of Michiana Shores to centerline of Old Grand Beach Road Thence southwesterly along the centerline of Old Grand Beach Road to the centerline of El Portal Drive Thence north along the centerline of El Portal Drive to the point of Beginning

POTTAWATTAMIE PARK

All that lies within the corporation limits of the town of Pottawattamie Park

All that part of the corporation of Wanatah that lies in Cass Township

Commencing at point on the south line of Clinton Township approximately 1325 feet east of the centerline of County Road 1100 West for the point of beginning Thence north approximately 1702 Thence east to the west right of way line of the former Monon Railroad Thence north along said right of way line to the north corporation limits of the town of Wanatah Thence east along the north corporation limits of the town of Wanatah and following the corporation limits to the south line of Clinton Township Thence west along the south line of Clinton Township to the point of beginning

WESTVILLE

Commencing at the intersection of the west right of way line of the former Monon Railroad and the centerline of County Road 250 North extended for the point of beginning Thence east along the centerline of County Road 250 North extended to the centerline of US Highway 421 Thence south along the centerline of US Highway 421

to the north corporation limits of the town of Westville as annexed by ordinance no927 and recorded in document number 1912704 recorded in the office of the LaPorte County Recorder Thence east along said north corporation limits and following the corporation limits to a point on the centerline of Circle Drive approximately 365 feet west of the centerline of US Highway 421 Thence south to the south line of New Durham Township Thence west along the south line of New Durham Township to a point approximately 955 feet west of the centerline of County Road 1100 West Thence north approximately 940 feet Thence west approximately 1170 feet Thence north approximately 7025 feet to a point on the westerly corporation limits of the town of Westville Thence west along the corporation limits of the town of Westville and following said corporation limits to the intersection of the north corporation limits with the west right of way line of the former Monon Railroad Thence continuing along said westerly right of way line to the point of beginning

CENTER 1

Commencing on the north line of Center Township and the centerline of US Highway 35 for the point of beginning Thence east along the north line of Center Township to the east line of Center Township Thence south along the east line of Center Township to the northerly corporation line of the city of LaPorte Thence easterly along the north line of the corporation limits of the city of LaPorte to the centerline of US Highway 35 Thence northwesterly along the centerline of US Highway 35 to the point of beginning

CENTER 2

Commencing the northwest corner of Center Township for the point of beginning Thence east along the north line of Center Township to the centerline of US Highway 35 Thence southeasterly along the centerline of US Highway 35 to its intersection with the centerline of Johnson Road Thence northwesterly along the center line of Johnson Road to the centerline of County Road 400 West Thence northerly along the centerline Of County Road 400 West to the center line of County Road 400 North Thence northwesterly along the centerline of County Road 400 North to the west line of Center Township Thence north along the west line of Center Township to the point of beginning

CENTER3

Commencing on the west line of Center Township and the centerline of County Road 400North for the point of beginning Thence southeasterly along the center line of County Road 400 North to the centerline of County Road 400 West Thence southerly along the centerline of County Road 400 West to the northerly right of way line of the US Highway 80 90 Thence southwesterly along said northerly right of way line to the west line of Center Township Thence north along the west line of Center Township to the point of beginning

CENTER 4

Commencing on the west line of Center Township and the northerly right of way line of US Highway 80/90 for the point of beginning Thence northeasterly along said northerly Right of way line to the centerline of Johnson Road Thence east along the centerline of Johnson Road to the centerline of County Road 400 West Thence south along the centerline of County Road 400 West to the centerline of Waverly Road Thence southeasterly along the centerline of Waverly Road to the westerly corporation limits of the city of LaPorte Thence westerly and following the corporation limits of the City of LaPorte to its intersection with the south line of Center Township Thence west along the south line of Center Township to the west line of Center Township Thence north along the west line of Center Township to the point of beginning

CENTER 5

Commencing at the centerline of County 400 West and the centerline of Johnson Road for the point of beginning Thence easterly along the centerline of Johnson Road to the westerly corporation limits of the City of LaPorte Thence southerly and following the westerly corporation limits of the city of LaPorte to its intersects with the centerline of Waverly Road Thence northwesterly along the centerline of Waverly Road to the centerline of County Road 400 West Thence north along the centerline of County Road 400 West to the point of beginning

COOLSPRING 1

Commencing at the intersection of the centerline of County Road 450 North and the centerline of Wozniak Road Thence northeasterly along the centerline of County Road 450 North to the centerline of Johnson Road Thence southeasterly along the centerline of Johnson Road to the east line of Coolspring Township Thence south along the east line Of Coolspring Township to the south line of Coolspring Township Thence west along the south line of Coolspring Township to the centerline of Wozniak Road Thence northerly along the centerline of Wozniak Road to the point of beginning

COOLSPRING 2

Commencing at a point where the centerline of County Road 300 North intersects the west line of LaPorte County for the point of beginning Thence east along the centerline of County Road 300 North to the centerline of US Highway 421 Thence south along the centerline of US Highway 421 to the intersection of County Road 200 North Thence easterly along County Road 200 North to the centerline of Wozniak Road Thence southerly along the centerline of Wozniak Road to the south line of Coolspring Township Thence west along the south line of Coolspring Township to the west line of LaPorte County Thence north along the west line of LaPorte County to the point of Beginning

COOLSPRING 3

Commencing at the intersection of Johnson Road and the southerly right of way line of Interstate 94 Thence easterly along the southerly right of way line of Interstate 94 to the east line of Coolspring Township Thence south along the east line of Coolspring Township to the centerline of Johnson Road Thence northwesterly along the centerline of Johnson Road to the centerline of County Road 450 North Thence west along the centerline of County Road 450 North to the centerline of Wozniak Road Thence north along the centerline of Wozniak Road to the southwesterly right of way line of Interstate 94 Thence southerly along said right of way line to the centerline of Johnson Road Thence northerly along the centerline of Johnson Road to the point of beginning

Commencing at the northwest corner of New Durham Township for the point of beginning Thence along the north line of New Durham Township to the centerline of Wozniak Road Thence southerly along the centerline of Wozniak Road to the centerline of State Road 2 Thence west along the centerline of State Road 2 to a point 394 east of the southwest corner of Section 16 Township 36 North Range 4 West being the southeast corner of a parcel of land as annexed to the town of Westville by ordinance no 927 recorded in document number 192074 in the office of the LaPorte County Recorder Thence north along the east line of afore mentioned parcel a distance of 450 feet Thence west along the north line of said parcel to the centerline of US Highway 421 Thence north along the centerline of US Highway 421 to the centerline of County Road 250 North extended Thence west along the centerline of County Road 250 North extended to the westerly right of way line of the former Monon Railroad Thence southerly along the westerly right of way line of the former Monon Railroad to the westerly corporation limits of the town of Westville Thence southerly along the westerly corporation limits of the town of Westville and following the westerly corporation limits of the town of Westville to a point where Coulter Road intersection the centerline of U S Highway 6 Thence northwesterly along the centerline of US Highway 6 to a point of the west corporation limit of the town of Westville Thence south along the west corporation limits of the town of Westville to the eastwesterly centerline of Section 30 Township 36 North Range 4 West Thence east approximately 768 feet Thence south approximately 7025 feet Thence east approximately 1170 feet Thence south approximately 940 feet to the south line of New Durham Township Thence west along the south line of New Durham Township to the west line of New Durham Township Thence north along the west line of New Durham Township to the point of beginning

NEW DURHAM 2

Commencing at the intersection of Wozniak Road and the north line of New Durham Township for the point of beginning Thence east along the north line of New Durham Township to the northeast corner of New Durham Township Thence south along the east line of New Durham Township to the south line of New Durham Township Thence west along the south line of New Durham Township to a point approximately 915 feet west of the centerline of US Highway 421 Thence north to a point on the centerline of Circle Drive approximately 365 feet west of the centerline of US Highway 421 Thence east along the corporation limits of the town of Westville and following the corporation limits of the town of Westville to its intersection with the centerline of State Road 2 Thence east along the centerline of State Road 2 to the intersection of Wozniak Road Thence northerly along the centerline of Wozniak Road to the point of beginning

BE IT FURTHER ORDAINED THAT:

1. All other ordinances in conflict herewith are expressly repealed.
2. Should any provision of this ordinance be held invalid, all other provisions contained herein shall be considered valid and remain in effect.
3. Unless otherwise stated, the description of the boundary lines used herein to delineate election precincts shall follow the centerline of all right of ways.
4. This ordinance shall be in full force and effect upon passage, approved and publication by the Board of Commissioners of LaPorte County.
