**ORDINANCE OF THE BOARD OF COMMISSIONERS OF LA PORTE COUNTY, INDIANA  
TO AMEND PRECINCT NAMES IN THE COUNTY COMMISSIONER DISTRICTS**

**WHEREAS**, the La Porte County Commissioners adopted Ordinance No. 2011-15 regarding the Precinct Names in the County Commissioners Districts;

**WHEREAS**, said Ordinance adopted Plan B and the description signed by the Commissioners was Plan A;

**WHEREAS**, the map made available to the public has always contained the correct Precincts in the corresponding County Commissioner Districts;

**WHEREAS**, the La Porte County Commissioners adopted Resolution No. 2014-14 on December 17, 2014 to Amend the Precinct names in the County Commissioner Districts;

**WHEREAS**, the La Porte County Voter Registration Office discovered the aforementioned Scrivener's errors contained in Ordinance No. 2011-15 and Resolution No. 2014-14 while reviewing the descriptions of the County Commissioner's District in all three (3) districts,

**WHEREAS**, the Precincts listed for the County Commissioners District requires this amendment to correct the aforementioned scrivener's error,

**NOW THEREFORE**, be it and it is hereby ordained by the La Porte County Commissioners as follow:

**DISTRICT 1:**


**DISTRICT 3:**


This Ordinance is effective upon passage.
