## ORDINANCE OF THE LAPORTE COUNTY BOARD OF COMMISSIONERS NO. 2015-2054

## ANIMAL CONTROL AGENCY- FEE COLLECTION

AN ORDINANCE OF THE BOARD OF COMMISSIONERS, LAPORTE COUNTY, INDIANA, PROVIDING FOR THE LAPORTE ANIMAL CONTROL ADVIOSRY BOARD TO ESTABLISH AND COLLECT FEES FOR SERVICES AS AUTHORIZED WITH THE ACCOUNTING AND TRANSFER OF SUCH FEES AS PROVIDED BY IC 16-1-4-24.

Be it Ordained by the Board of Commissioners of LaPorte County, State of Indiana, that:

SECTION L. The LaPorte Animal Control Advisory Board is empowered to establish and collect fees in accord with the following definitions and provisions.

SECTION II. Definitions: The following definitions shall apply in the interpretation and enforcement of this Ordinance:

- A. The term "board" as used herein shall mean the LaPorte Animal Control Advisory Board as provided for in LaPorte County Resolution 89-5.
- B. The term "animal control agency" means any governmental or private entity charged with or contracted with and given authority for the enforcement on the provisions of this Ordinance for and on behalf of the County of LaPorte.
- C. The term "animal control officer" shall mean the county animal control officer as provided for in LaPorte County Resolution 89-5.
- D. The term "authorized representative" shall mean an agent in principle of the board and/or animal control officer.
- E. The term "person" shall mean any individual, partnership, co-partnership, firm, company, corporation or association.

## SECTION III. Fees for Services

The Animal Control Advisory Board having jurisdiction may charge a service fee not in the excess of the cost for providing to any person, who owns an animal or animal for the care of domestic animals that are under the custody of the LaPorte Animal Shelter, specifically a fee will be charged for shots and various medicines.

SECTION IV. Collection Accounting and Disposition

- A. Collection of fees: The board shall collect such fees established as a part of this ordinance in accord with the following schedule and accordingly for various medicines:

- B. Accounting for fees: All fees collected by the board shall be accounted for in detail for each service provided.
- C. Disposition of Fees: All fees collected by the board shall be transferred to the LaPorte County Animal Control Non-Reverting Fund. The monies collected in accord with the provisions of this Ordinance shall be used only for the maintenance of future expansion of the program from which they were derived.

## SECTION V. Unconstitutionality Clause

Should any section, paragraph, clause, or phrase of this ordinance be declared unconstitutional or invalid, the remainder of the said Ordinance shall not be affected thereby.

SECTION VI. Repeal and Date of Effect

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed, and this ordinance shall be in full force and effect as of
