

NOW, THEREFORE, BE IT RESOLVED BY THE LAPORTE COUNTY, INDIANA BOARD OF COMMISSIONERS:


1. That LaPorte County, Indiana by and through its Board of Commissioners hereby approves the assignment of the tax sale certificates held by the County to the City of La Porte, Indiana for the properties described in **Exhibit A** attached hereto.
2. That all taxes, penalties and assessments against the properties described herein shall be waived for the tax year 2018 payable 2019 and prior as to the City of La Porte, Indiana.
3. That the period of redemption of the properties described herein shall be for one hundred twenty (120) days from the date the certificates are assigned, pursuant to applicable law.




