**June 28, 2010**

The LaPorte County Council Meeting was held on Monday, June 28, 2010 at 6:30 p.m. in the Assembly Room of the LaPorte County Government Complex, 809 State Street, LaPorte, Indiana 46350.

Meeting was called to order by Council President, Mark Yagelski

Roll Call was taken by Auditor, Craig Hinchman. Those attending were Mr. Bernacchi, Mr. Cunningham, Mr. Garner, Mr. Ford, Mr. Mrozinski, and Mr. Yagelski. Also present were Chief Deputy Auditor, Mary Ray and Council Attorney Don Baugher. Mrs. Sosinski was absent.
