

## **LAPORTE COUNTY COUNCIL MEETING**

**APRIL 18, 2011**

The LaPorte County Council Meeting was held on Monday, April 18, 2011 at 6:30 p.m. in the Assembly Room of the LaPorte County Government Complex, 809 State Street, LaPorte, Indiana 46350.

Meeting was called to order by Council President

Pledge of Allegiance was recited

Auditor, Craig Hinchman called the roll; all Council members were present along with Chief Deputy, Mary Ray and Attorney, Doug Biege, co-council.

All members approved the amended agenda.

All members approved the March 14, and March 21, 2011 Council minutes

Department Head Reports

County Surveyor, Tony Hendricks spoke briefly on the need for a different vehicle for his department. He stated that the vehicle he has is beyond repair and a safety hazard. This topic will be on the May 23, 2011 agenda.

Liaison Reports

Mrs. Sosinski met with the data board regarding software that is not being utilized. She reported that there is software available that is much improved. It would allow the offices to communicate with each other through the computer, saving time on duplication.

Mr. Yagelski reported that he met with the NICTD Board. He stated that funds were given to Trans Systems for the study of moving the South Shore route through Michigan City. He also stated that the new Purdue Extension building must be handicapped accessible. Commissioner, Ken Layton reported that most of the County buildings are now handicap accessible. The County is working to be 100 percent, but the balances of upgrades are very expensive.

Mr. Bernacchi met with the Assessor and reported that Tyler group has hired eight full time employees and two part time employees. Eight people are local hires. Re-assessment is approximately 20% complete. He also met with the Treasurer on the status of the reconciliation bills. There have been many taxpayer calls with concerns. Some bills that stated zero balance actually have a credit rolled to the next year. New provisional bills are going to be due on approximately June 24, 2011 if the legislature passes a bill to allow this.

Mr. Cunningham had no report.

Mr. Ford is meeting with Emergency Management Director, Fran Tibbit regarding the narrow banding project.

Mr. Garner reported that the City of LaPorte is asking for the County Police Officers to help during the Fourth of July Parade. He also reported meeting with Mr. Al Ott regarding the use of jail supplies. He stated over half of the budget has been spent already.

Mr. Mrozinski reported that the KIDC project contract is getting very close to being signed. He also reported that twenty LaPorte County Veterans received medals this month. He also attended meetings regarding Solid Waste, Leadership, Economic development and PNC for the Campus Veterans Project.
