

RESOLUTION NO. 2015-4A

**RESOLUTION OF THE LAPORTE COUNTY COUNCIL
REGARDING APPOINTMENTS TO THE
LAPORTE COUNTY REDEVELOPMENT COMMISSION**

WHEREAS, IC 36-7-14 (the "Act") authorizes the Board of Commissioners (the "Board") and the County Council (the "Council") of LaPorte County, Indiana (the "County") to appoint the commissioners for the LaPorte County Redevelopment Commission (the "Redevelopment Commission") pursuant to Section 6.1(b) and Section 6.1(c) of the Act; and

WHEREAS, the appointment of certain commissioners of the Redevelopment Commission for terms of office beginning after December 31, 2007, may not have previously been approved by the Council; and

WHEREAS, the Council now desires to ratify and approve the appointment of each of the individuals identified on Exhibit A hereto as commissioners of the Redevelopment Commission for the term or terms of office set forth next to their names thereon in accordance with Section 6.1(b)(2) of the Act.

NOW, THEREFORE, BE IT RESOLVED BY THE LAPORTE COUNTY COUNCIL, AS FOLLOWS:

1. The recitals contained in this Resolution are true and correct and are incorporated in this Resolution by this reference.

2. The Council hereby ratifies and approves the appointment of each of the individuals identified on Exhibit A hereto as commissioners of the Redevelopment Commission for the term or terms of office set forth next to their names thereon in accordance with Section 6.1(b)(2) of the Act.

3. This Resolution shall be in full force and effect from and after its passage by the Council in the manner provided by law.
