OLD BUSINESS

- **A.** <u>Marketing Contract update:</u> Shaw Friedman; Commission Attorney indicated that according to a recent discussion with Dave Christian; LaPorte County Office of Economic Development Director, the marketing contract is moving forward as the Commission has authorized.
- **B.** <u>KIP Update:</u> Joe Coar reported that according to conversations with Dave Christian, Of LaPorte County Office of Economic Development Director businesses are calling with interest in KIP.

NEW BUSINESS

- **A.** Consideration of payment for Cender & Company: \$710 and \$6,763.25: Joe Coar: Commission President presented a claim to Cender & Company in the amount of \$710 and \$6,763.25. Vidya Kora moved to approve the payment to Cender and Company for \$710 and \$6,763.25 as presented. Matthew Bernacchi seconded the motion. The motion unanimously carried.

D. Update negotiations on global easement agreement for KIP to be

controlled/administered by RDC: Shaw Friedman; Commission Attorney explained progress is continuing at KIP on the global easement agreement with work by Meridian Title and Barnes & Thornburg. Meridian Title is working to pull all the easements into a single document. Most of the easements documents are complete with a proposed list of conditions to present to Commission hopefully at the next Commission meeting.

Mr. Friedman reported Dave Christian; Office of Redevelopment Commission Director and he are working on meeting with CSX representatives. A proposal to the State of Indiana for funding will probably be likely in the future for the CSX rail connection, CN Bridge and the completion of the Economic Development Corridor study.

Patricia Harris questioned if there will be a committee to manage this agreement. After some discussion, Patricia Harris requested a committee be formed to review the agreement before it is brought back to the Commission. Vidya Kora motioned to authorize the Commission President; Joe Coar to work with Dave Christian; LaPorte County Office of Economic Development Director to create a committee of 3 Commission representatives to review the agreement before it is presented to the Commission. Patricia Harris seconded the motion. The motion unanimously carried.
