# **APPROVAL OF MINUTES**

The October 5, 2016 special meeting minutes were reviewed. Vidya Kora motioned to approve the October 5, 2016 special meeting minutes as presented. Terry Larson seconded the motion. The motion carried unanimously.

## **TREASURER'S REPORT**

Joe Cora reported that a Treasurer's Report is not available, however in July the balance of funds was \$177,000 and should be enough to cover the claims presented to the Board for consideration.

## **OLD BUSINESS**

- A. <u>Marketing Contract update:</u> Dave Christian; La Porte County Redevelopment Director introduced the President of Propeller Marketing, Jocelyn Vare. Jocelyn gave a presentation to the Board on the accomplishments of the marketing contract with the La Porte County Office of Economic Development. The accomplishments include branding strategy, new logo and tagline, graphic standards, marketing plan, office letterhead, brochure, and a new website. Jocelyn stated there is still enough money left on the contract to perform Google analytics, press release, finalize the website, create social media presence and a newsletter.
- B. KIP Global Agreement Update-Consideration of Release of Mortgage (La Porte ILPK Kingbusy), KIP Agreement (La Porte County), Bill of Sale (La Porte County\_Kingsbury), Termination of Declaration (La Porte County\_KIP), Assignments of Easements Agreements (La Porte County\_Halfwassen), Declaration of Restriction and Covenants (La Porte County\_Kingsbury), Quit Claim Deed-KIP (La Porte County\_ILPK), Corrective Deed-Kip (La Porte County\_ILPK): Shaw Friedman; Commission Attorney explained the County Council and County Commissions have approved the agreements unanimously. The Resolution before the Board gives authorization for the counteroffer to the original Halfwassen proposal. Mr. Phil Paccenda and Mr. Mike Hardy; Barnes & Thornburg reported the restructuring of the agreement is the release of the Halfwassen loan and in return they give all rail spur property rights to the County. This will allow for a better chance of having the loan repaid through TIF revenues and La Porte County will be the neutral independent third party managing the rail spur. The original Declaration will be terminated and a new Declaration created. There are parts of the Declaration yet to be negotiated which include the Allocation Schedule and Development standards. The Development

Standards are met to spur growth not prohibit growth. There will need to be a subcommittee to oversee the development standards.
