TREASURER'S REPORT

President Coar stated there was no available Treasury Report this month. President Coar announced that the Resolutions approved last month by the Redevelopment Commission to pledge and restructure the KIP and I94/U.S. 421 loans to the La Porte County Major Moves Construction Fund were approved at the recent Commissioners and Council meetings.

B. Hupp Road Update - Brad Adamsky

Brad Adamsky representing Newby, Lewis, Kaminski & Jones, LLP updated the Redevelopment Commission on the Hupp Road construction update. Mr. Adamski stated he met with the affected property owners in July of 2017 to discuss the details of the property transfers that are needed to complete the Hupp Road construction that is planned. President Coar asked if there was anything the Redevelopment Commission can do to help the situation. Discussion ensued regarding the rail and the widening of Hupp Rd. President Coar asked if Mr. Adamski would return with another update of the situation next month.
