OLD BUSINESS

A. <u>CRPC Sub-Committee Report</u>

Russ Klosinski gave a report of recent activities by the Sub-Committee. The activities included gathering information for the final draft of the Switching Request for Proposal and the Track Maintenance Request for Proposal. President Coar commended the work done by the Sub-Committee.

B. Final Approval – Switching RFP

President Coar explained he was contacted prior to the meeting with information that there are hunting stands that appear to be on the county track easements. Mr. Mike Seitz mentioned that the DNR requested an affidavit from the county stating that there should be no hunting on county property. Attorney Doug Biege stated he could follow through with the DNR's request. Attorney Friedman requested the Redevelopment Commission and the Rail Committee motion to approve that there is no hunting permitted in the Kingsbury Industrial Park also. Discussion ensued regarding hunting near the tracks and the industrial park. Jeff Johnson motioned for Attorneys Doug Biege and Shaw Friedman to research the probability of restricting hunting on private property near the Kingsbury Industrial Park. Tom Dermody seconded the motion. The motion carried unanimously.

Attorney Biege gave an update on the status of the liability insurance for the county owned rail track and easements He stated the liability insurance carrier has requested the track legal description prior to quoting the policy. Attorney Biege informed the Commission that the legal description will be available soon.

Attorney Biege gave an update on the Hupp Road easements. He noted that 12 out of 21 landowners have given deeds to the county for the right of way easements and he expects the remainder should be completed by the end of the year.
