WHEREAS, the La Porte County Council is the statutory body with the authority to designate an area within its jurisdiction as an economic revitalization area as defined in IND. CODE 6-1.1-12.1-1

WHEREAS, a petition for real property tax abatement has been filed with and for consideration by the La Porte County Council requesting that the following described property in La Porte Indiana:

NOW THEREFORE, IT IS HEREBY RESOLVED BY THE LA PORTE COUNTY COUNCIL THAT:

Section 1. The La Porte County Council now finds that the benefits described in the statement of benefits filed in regard to this area can be reasonably expected to the result from the project and are sufficient to justify the applicable deduction in the event the above-referenced property is designated and confirmed to be an economic revitalization area.

Section 2. The area described hereinabove and located within La Porte is hereby declared to be an economic revitalization area, pursuant to IND CODE 6-1.1-12.1-1

Section 3. The designation of this area is put in effect for a period of ten years from the passage of the confirmation of this resolution.

Section 4. This resolution shall be in full force and effect from and after its passage and approval and confirmation, as required by law.
