President Novak read the claims as presented for payment for the Kingsbury Industrial Park TIF area from the Claim Docket. Dr. Vidya Kora motioned to approve the Kingsbury Industrial Park TIF area claims in the amount of \$9,906.71. Terry Larson seconded the motion. The motion carried unanimously.

President Novak read the claims as presented for payment for the US 421 #1 TIF area from the Claim Docket. Dr. Vidya Kora motioned to approve the US 421 #1 TIF area claims in the amount of \$4,321.91. Terry Larson seconded the motion. The motion carried unanimously.

President Novak read the claims as presented for payment for the 39 North TIF area from the Claim Docket. Dr. Vidya Kora motioned to approve the 39 North TIF area claims in the amount of \$1,000.00. Terry Larson seconded the motion. The motion carried unanimously.

#### **OLD BUSINESS**

### A. 421/I94 TIF Project Update – Matt Reardon; MCR Partners

Mr. Matt Reardon announced TransCanada Pipeline and 421 Partners, LLC have resolved the matter related to the underground pipeline on the property. He added, along with Love's Travel Center, Lower Great Lakes Kenworth, Inc. has chosen this site for their new locations. He continued the proposed development has an estimated cost of \$23 - \$25 million.

Mr. Reardon stated La Porte County Planner Mitch Bishop and County Engineer Mr. Jerry Sullivan are reviewing the Hwy 421/I94 Water and Sewer Extension Project plans in order to provide an updated cost estimate to the La Porte Redevelopment Commission. Mr. Reardon requested authorization for Cender & Company to move forward with an update on the tax revenue projections and bond counsel to begin preparation of the bond documents with a firm recommitment from the developer, 421 Partners, LLC, in writing. He added Cender & Company will assist in identifying any additional funding that may be necessary to complete the project. President Novak requested that Mr. Reardon connect with Michigan City Water and Sanitary to ensure their commitment to the project as well and to confirm their approval of the utility extension plans. Dr. Kora asked Mr. Reardon for a status update related to the funds contributed to the project by potential users of the extended water and sewer lines. Mr. Reardon answered that those funds are being held with the county auditor and that some potential users have not contributed yet but have verbally committed to do so.

Dr. Vidya Kora motioned to reopen the Hwy 421/I94 project's hard stop, authorize Cender and Company to prepare an updated projection of new TIF tax revenue and to authorize Matt Reardon to proceed with issues related to the water and sewer extension plans for the area upon President Novak's approval of a firm commitment letter by 421 Partners, LLC. Terry Larson seconded the motion. The motion carried unanimously.

#### B. KIP Update - Matt Reardon; MCR Partners

Mr. Reardon deferred to Attorney Friedman for an update on the county's offer to purchase property related to the CN connection on Kingsbury Industrial Park's (KIP) north side. Attorney Friedman announced along with the recent award of an IEDC grant to assist with the CSX rail connectivity in KIP, a formal offer to purchase property related to the CN rail has been prepared by Attorney Michael Bergerson, Barnes & Thornburg. As Attorney Bergerson was introduced, he congratulated Mr. Reardon's team for a great job preparing the appraisal and offer of the property. He added a formal offer letter according to required statutes has been prepared with a purchase price offer of \$40,400. Attorney Bergerson requested authorization to move forward with the formal offer, conduct any

negotiations and any related legal actions. Attorney Friedman reminded the La Porte County Redevelopment Commission is required by law to make a good faith offer for the property.

Dr. Kora mentioned the purpose of acquiring this land is for the public good, prudent from the taxpayer's standpoint and is only asking for minimal land needed for an easement to complete the track improvements. Dr. Vidya Kora motioned to authorize Barnes & Thornburg to proceed with the formal offer letter at a purchase price of \$40,500. Michael Rosenbaum seconded. The motion carried unanimously. Michael Rosenbaum added two (2) appraisals were performed and the higher appraisal amount is being offered as a good faith effort.

# C. 39 N Water Tower- Matt Reardon; MCR Partners

Mr. Reardon stated he attended the La Porte County Council meeting last night and heard Mr. Wallace speak of his drainage problem which will be added as an emergency issue on the EDA grant application. Attorney Friedman added that both an EDA grant and IFA grant should be pursued to maximize the possibility of securing funds towards a new 39 North Conservancy District water tower. He added he will assist in the communication between Krieg DeVault LLP, Mr. Jim McGoff (IFA COO & Director of Environmental Programs) and the 39 North Conservancy District's engineering firm, VS Engineering. President Novak confirmed the Redevelopment Commission only pays for the EDA grant effort and Attorney Friedman added the IFA loan and grant effort is being paid by the 39 North Conservancy District.

## D. 35 TIF - Matt Reardon; MCR Partners

Mr. Reardon stated a 35 TIF map with parcels identified, site plan, development plan and estimated cost for infrastructure has been provided to the Redevelopment Commission and a timeline would be created internally when, and if, instructed to do so. President Novak inquired to any cost and Mr. Reardon responded there would be no cost, the hard work is done already.

#### **NEW BUSINESS**

Mr. Reardon provided an update on the economic development activity in La Porte County. He added at least twelve (12) recent leads by the State of Indiana have been reviewed and some leads are particular to other counties. He stated it seems there is a lack of move-in ready buildings causing companies to look at other areas while some have shown interest in Kingsbury Industrial Park and 39 North when searching for vacant land. He mentioned if they feel a company is a good fit for Michigan City or the City of La Porte, they do reach out to the city with that information.
