**A RESOLUTION ASSIGNING TAX SALE CERTIFICATE  
TO THE TOWN OF KINGSBURY, INDIANA**

**WHEREAS**, LaPorte County, Indiana, by and through its Board of Commissioners, is the holder of the tax sale certificate for the property described in **Exhibit A** attached hereto;

**WHEREAS**, pursuant to I.C. 6-1.1-24-9, the LaPorte County Board of Commissioners may assign tax sale certificates held in the name of the county executive to any political subdivision;

**WHEREAS**, the Town of Kingsbury, Indiana has expressed a desire to obtain the tax sale certificate for the property described in **Exhibit A** and has requested from the LaPorte County Board of Commissioners an assignment of that certain tax sale certificate; and

**WHEREAS**, it is a benefit to both LaPorte County and the Town of Kingsbury that the tax sale certificate for the property described in **Exhibit A** now be assigned to the Town of Kingsbury, Indiana.

NOW, THEREFORE, **BE IT RESOLVED** BY THE LAPORTE COUNTY, INDIANA BOARD OF COMMISSIONERS:

1. That LaPorte County, Indiana by and through its Board of Commissioners hereby approves the assignment of the tax sale certificate held by the county to the Town of Kingsbury, Indiana for the property described in **Exhibit A** attached hereto.
2. That all taxes, penalties and assessments against the property described herein shall be removed for the tax year 2020 payable 2021 and prior as to the Town of Kingsbury, Indiana.
3. That the period of redemption of the property described herein shall be for one hundred twenty (120) days from the date the certificate is assigned pursuant to applicable law.




