WHEREAS, the LaPorte County Council is the statutory body with the authority to designate an area(s) within its jurisdiction as an Economic Revitalization Area(s) as defined in I.C. § 6-1.1-12.1-1, *et.seq.*; and,

WHEREAS, It has been determined by the LaPorte County Council that creating an Economic Revitalization Area(s) in the County will help promote development, redevelopment, investment and job creation; and,

WHEREAS, the LaPorte County Council has identified such area(s) in LaPorte County, Indiana, State Tax Parcel Identification be considered for the creation of an Economic Revitalization Area(s);

A Parcel of Real Property in Coolspring Township, LaPorte County, Indiana more particularly described for tax purposes as IN W 1/2 SE 1/4 S OF ROAD S6 T37 R4. 33.69 A., comprising a total of 33.69 acres (more or less) taxed as Parcel Key No. 11-05-06-400-001;




