President Kiel read the JBC Rail claim as presented for payment for the KIDC Bridge Project/READI Grant from the Claim Docket. Mark Parkman motioned to approve the JBC Rail claim in the amount of \$216,355.63. Randy Novak seconded the motion. The motion carried unanimously.

OLD BUSINESS

A. 421/I94 TIF Project Update - Matt Reardon; MCR Partners

Mr. Reardon read a construction update provided by Mr. Mitch Bishop, County Planner, as follows: sewer taps on County Road 300 have been completed, asphalt completed today for those areas, still waiting on AT&T utility relocation and grass restoration has begun.

Mr. Reardon provided an update on the proposed Great Lakes Capital development near 194 and CR 400. There have been negotiations related to the exterior's appearance such as tilt up concrete is lieu of a metal exterior, as proposed. He added the zoning matches well with the proposed business.

Randy Novak asked for an update on the 421 Partners contribution. Mr. Reardon stated no check has been received yet. Vladimir Ganz has been made aware that no water or sewer service connection will be allowed until payment is made.

B. Kingsbury Industrial Park (KIP) Update - Matt Reardon; MCR Partners

Mr. Reardon reported a large company has an interest in developing property at the Kingsbury Industrial Park. Project Phoenix is a billion-dollar investment with its electric and gas use aligning with NIPSCO's capabilities.

Mr. Reardon stated the CSX agreement will soon be fully executed with only one signature needed at this time.

Mr. Reardon reported Attorney Guy DiMartino and Attorney Doug Biege will be leading the road improvement initiative. He added if the property owners will not provide easements, eminent domain may be required, which is expensive for the county. Attorney DiMartino stated hopefully it does not come to that as the improvements will only assist in developing the remainder of the industrial park and increase property values in the area. Mark Parkman asked if it would be inappropriate for members to call the property owners, as some are known to them, about the benefits of signing over an easement for road improvements. Attorney DiMartino stated not at all, it would be beneficial to chat with the property owners.

C. 39 N Update - Matt Reardon; MCR Partners

Mr. Reardon reported there have been discussions between the City of La Porte and the company related to the availability of water and sewer utilities. He explained the county TIF could be reconstructed due to the city's annexation of the property. The project is an \$80 million investment for the area. President Kiel asked if the city was leaning towards annexing the property. Mr. Reardon stated he did not know. MIchael Rosenbaum mentioned he attended a recent City of La Porte Council meeting in which the project was discussed, and the project is moving forward although the process can take some time.

D. 35/194 Update - Matt Reardon; MCR Partners

Mr. Reardon reported the state of Indiana is rebuilding the visitor's center and water & sewer utilities will need to be extended to the center from Michigan City. Mr. Reardon added other properties in the same area could potentially benefit from the extension of utilities.

NEW BUSINESS

A. Construction Rail Planning Committee appointments – RDC Attorney

Attorney DiMartino explained the need to appoint the Construction Rail Planning Committee members. Attorney Doug Biege added his client, CN Railroad, has completed the construction plans and is ready to move forward. President Kiel opened the floor for appointments. Michael Rosenbaum, William Dobbins, Rich Mrozinski, Joe Coar, Tom Fath, Justin Kiel, and Engineer Jay

Sullivan were named. President Kiel closed the floor for appointments. Vice-President Novak motioned to appoint Michael Rosenbaum, William Dobbins, Rich Mrozinski, Joe Coar, Tom Fath, Justin Kiel, and Engineer Jay Sullivan. Scott Cooley seconded the motion. The motion carried unanimously.

B. Kingsbury Elevator Rail Project - Doug Biege

Attorney Doug Biege explained that CN Railroad has approved the construction plans and he recommends the Construction Rail Planning Committee waive any additional engineering reviews as he considers it an unnecessary cost and delay. Phase I construction is now beginning, and Phase 2 is expected by next summer. Attorney DiMartino confirmed the groundbreaking currently is only on Kingsbury's property. Attorney Biege responded yes. Mark Parkman asked who will own the rail after the construction. Attorney DiMartino added that is to be negotiated. Attorney Biege added he has an inquiry into Assessor Mike Schultz's office related to the taxation of Kingsbury Industrial Park's rail and whether it is being treated as personal property. Mr. Reardon stated it should not be taxable. Attorney Biege will attend future Redevelopment Commission meetings until rail construction has been completed.

OTHER BUSINESS

President Kiel reported that he, along with Mr. Rosenbaum, attended a recent IAC meeting that included residential TIF training and asked Mr. Reardon to provide an overview and potential aspects for the county to explore. Mr. Reardon explained residential TIF's provide for new residential developments in areas where developers cannot afford to undertake the upfront infrastructure cost. Private bonds are issued to the developer with repayment of the bonds coming from property tax revenue generated from the new homes. He added the town of Hebron has recently created two (2) Residential TIFs and new homes are currently under construction. Mr. Reardon will gather pertinent information for the members to review.

President Keil also reported that at the IAC meeting House Bill 1454 – Annual Spending Plan was discussed. Mr. Reardon confirmed MCR Partners is aware of the new requirement and will ensure the county's compliance with the new law.

ADJOURNMENT

Michael Rosenbaum motioned to adjourn the meeting at 5:08pm. Scott Cooley seconded the motion. The motion carried unanimously. The next meeting will be held July 26, 2023.
