President Kiel read the claims as presented for payment for the US 421 #1 TIF area from the Claim Docket. Rich Mrozinski motioned to approve the US 421 #1 TIF area claims in the amount of \$4,241.00. Michael Rosenbaum seconded the motion. The motion carried unanimously.

President Kiel read the claims as presented for payment for the 39 North TIF area from the Claim Docket. Rich Mrozinksi motioned to approve the 39 North TIF area claims in the amount of \$1,000.00. Michael Rosenbaum seconded the motion. The motion carried unanimously.

President Kiel read the CSX claim as presented for payment for the KIDC CSX Switch from the Claim Docket. Rich Mrozinski motioned to approve the CSX claim in the amount of \$525,000.00 Michael Rosenbaum seconded the motion. The motion carried unanimously.

OLD BUSINESS

1. 421/194 TIF Project Update - Matt Reardon; MCR Partners

Mr. Reardon reported the US 421/I94 Utility Project has been delayed due to an AT&T utility relocation issue and plans to meet with D&M Excavating and Mr. Mitch Bishop, County Planner, to wrap up the project very soon. Mr. Reardon reported the \$75,000 contribution to the project has not been paid by 421 Partners. Vice President Novak mentioned the Love's Travel Center is under construction. Mr. Reardon responded that no water or sewer service connection will be allowed until payment is made.

Mr. Reardon stated there has been no movement on the potential warehouse project.

2. Kingsbury Industrial Park (KIP) Update - Matt Reardon; MCR Partners

Mr. Reardon reported the Construction Rail Planning Committee met earlier to review the Joint Agreement between JBC Rail Services, Kingsbury Elevator and the LaPorte County Redevelopment Commission for the reimbursement of funding the CSX rail connection.

Mr. Reardon also reported that MCR Partners responded to four (4) larger-scale projects with interest inside the Kingsbury Industrial Park. One of these projects has visited KIP and the community three (3) times to evaluate site possibilities.

3. 39 N Update - Matt Reardon; MCR Partners

Mr. Reardon reported MCR Partners continues to work with 2 potential companies with an interest in the 39 North TIF area. Negotiations are currently ongoing for the purchase of the property as well as the availability of water and sewer service from the City of LaPorte and/or the 39 North Conservancy District.

4. 35/194 Update - Matt Reardon; MCR Partners

Mr. Reardon reported projects are on hold until the City of Michigan City makes a decision related to the extension of water & sewer utilities.

NEW BUSINESS

1. Consideration of the Construction Rail Planning Committee (CRPC) Report

Attorney Doug Biege, Drayton, Biege, Sirugo & Elliott, LLP, reported the Construction Rail Planning Committee (CRPC) reviewed CN's rail plans and found them to be sufficient. Therefore, Mr. Biege requested approval of the CRPC Report related to the favorable recommendation of the CN rail plans. Rich Mrozinski motioned to approve the CRPC Report related to the favorable recommendation of the CN rail plans. Mark Parkman seconded the motion. The motion carried unanimously.

2. Confirmation of Joint Agreement Kingsbury Industrial Park CSX Rail Connection Reimbursement LaPorte County Redevelopment Commission, JBC Rail Services, Inc. and Kingsbury Elevator, Inc.

Attorney Doug Biege also explained the need for a 100-year Easement Agreement between Kingsbury Elevator and La Porte County, with Kingsbury Elevator maintaining the track. Attorney DiMartino added this easement agreement removes the County from the rail business and he recommended approval of the easement agreement pending his second review of the document. Michael Rosenbaum motioned to approve the Kingsbury Elevator/ La Porte County 100-year Easement Agreement after a second legal review by Attorney DiMartino. Rich Mrozinski seconded the motion. The motion carried unanimously.

3. Consideration of KIP TIF creation from Jim Ventura, Kingsbury Biofuels

Mr. Reardon explained Kingsbury Biofuels has received the proper approvals from the La Porte County Plan Commission and Board of Zoning Appeals for the operation of the business on a prospective parcel in the KIP, in addition all required permits have been issued by IDEM. Kingsbury Biofuels is requesting incentives for the project such as private use of a TIF with the developer purchasing the bonds. Mr. Reardon also stated Kingsbury Biofuels is most likely eligible for an environmental tax-exempt waiver on personal and property taxes and if they refuse the waiver, the county will continue to receive personal and real property taxes. Mr. Ventura responded they would refuse the waiver in exchange for incentives for the project.

Jim Ventura, Kingsbury Biofuels, and Ted Niblock, Vice President of Nexus W2V, gave a presentation on the operation of Kingsbury Biofuels. Mr. Niblock stated Kingsbury Biofuels has contracted with a long term purchaser for the renewable energy that will be produced and nearly completed the discussions with the construction contractors. The facility will be an anaerobic digester facility. An anaerobic digester uses organic material which is placed in a 2,000,000-gallon tank that deprives it of oxygen, and the bacteria that grows on the organic material consumes the waste and produces methane. The methane is captured, cleaned to pipeline-grade gas, and injected into a carrier's gas pipeline system. Methane gas displaces a small amount of natural gas from fossil sources. The cost of injecting the methane gas into NIPSCO's natural gas pipeline is approximately \$5.4 million. Mark Parkman asked if the methane gas product burns like natural gas. Mr. Niblock responded yes: Mr. Parkman asked how much will be produced. Mr. Niblock responded 200,000 Mmcf per year. Ms. Rhonda Spence asked who the customer is. Mr. Niblock responded their customer is a very large Canadian energy company and a 10-year fixed price is locked into the contract. Secretary Michael Rosenbaum asked how many jobs would be created by the project. Mr. Niblock

responded approximately 88-93 jobs. Michael Rosenbaum asked how many trucks entering and exiting the facility per day. Mr. Niblock responded with about 8 trucks per day, 6 days per week. Michael Rosenbaum asked if the company plans to use rail. Mr. Niblock responded there are no plans to use rail but would be a possibility in the future. Michael Rosenbaum asked if the facility requires additional fire protection. Mr. Niblock responded additional fire protection is not usually needed but they will contact the area's fire departments. Michael Rosenbaum asked if unpleasant smells come with the operation of the facility. Mr. Niblock responded that any smell would not normally exceed the fence line, although unpleasant smells could occur from trucks entering and exiting the building. President Kiel thanked both gentlemen for attending the meeting and explaining the potential project.
