La Porte County Commissioners' Meeting Minutes Wednesday, November 1, 2023 at 10:00 a.m. County Complex Room 3 & via Zoom

President Connie Gramarossa called the meeting to order at 10:00 a.m. followed by the Pledge of Allegiance.

Deputy Auditor Rhonda Graves called the roll: Commissioner Connie Gramarossa - Present; Commissioner Rich Mrozinski - Present; Commissioner Joe Haney - Present. Quorum present therefore meeting commenced.

Considered the agenda. Commissioner Haney motioned to add to the agenda Resolution 2023-09 in reference to the old Prison Cemetery in Michigan City approved several meetings ago. Attorney Guy DiMartino, sitting in for Attorney Scott Pejic, stated the Resolution was approved and passed. Commissioner Haney motioned to amend his motion by accepting the agenda as is, Commissioner Mrozinski seconded. Motion carried 3-0.

Considered approval of the October 18, 2023 minutes. Commissioner Mrozinski motioned to approve. Commissioner Haney seconded. Motion carried 3-0.

Department Reports/Comments

Jerry Sullivan, reported on the E Street Bridge in Michigan City, the bridge is on a two-year schedule to be inspected. Service ability is rated high with structural integrity, and is in good shape. Waiting on a consultant about the rust under the bridge. Resurfacing may be next year.

Stacey Sweitzer, Deputy Assessor, the Beacon site is paid for by the Assessor's office but is free to use, do not use the information for legal use though, it is a helpful tool. Beacon is 'live' and that means when a change is made to a parcel, typically done in the Real Estate office, the Assessor's office is next then to make the changes. When a change is made, whether it be an annexation, a split or a combine, the parcel number can change. Once the parcel number changes, the old or original parcel number is no longer available for viewing on the Beacon site. The tax information or any other information will not be available until January 1st on the new parcel after changes are made. Guidelines by the DLGF are followed.

Matt Reardon, Economic Development, reported briefly on the utility project at 94/421 that is almost complete, this will allow development between Michigan City and Purdue Northwest in Westville. In Kingsbury, the 'ready project' has been completed. Matching grants with JBC Rail and Kingsbury Elevator are underway, funds have been allocated to CSX Railroad to complete the loop for two Class 1s running in the park in 2024.

Commissioner Rich Mrozinski, Courthouse Security Committee, reviewed an Ordinance that includes County Employees going through the metal detector when entering the two courthouses. This is a possibility for the future. Reminded everyone that winter will be arriving soon, remember those clearing the roads for us, slow down. Veterans' program will be at the Civic Auditorium on Friday, November 10th at 10:30 a.m. Stated the old highway garage in Rolling Prairie could potentially be a county park. He then welcomed students from South Central High School, Tri-Township Schools, North Judson and Valpo schools.

Commissioner Joe Haney, two and a half years ago the old Rolling Prairie highway garage was thought about for a possible county park. Hopefully the Council will find the money to fund it. He welcomed Commissioner Mrozinski back.

Considered Memorandum of Agreement with Michigan City for transfer of Road Maintenance which includes plowing and maintenance of roads. Commissioner Mrozinski motioned to approve. Commissioner Haney seconded. Motion carried 3-0. Reviewed by Attorney Guy DiMartino.
