ORDINANCE NO. 2024-8

AMENDING THE ZONING MAP OF LA PORTE COUNTY, INDIANA TO REZONE CERTAIN PROPERTY LOCATED IN COOLSPRING TOWNSHIP FROM R1A TO A

WHEREAS, Andrew E. Skwiat (the "Petitioner") filed a Petition (the "Petition") with the La Porte County Plan Commission (the "Plan Commission") on November 26, 2024 asking that certain property in Coolspring Township in La Porte County be rezoned from R1A to A, namely, property with a common address of 1655 North Shebel Road, Michigan City, IN 46360, and Parcel ID of 46-05-27-300-002.000-046 (the "Property"), which Property is located largely between W 200 N to the north, Wozniak Road to the east, W Division Rd to the south, and W Shebel Road to the west, and which Property is legally described on Exhibit 1 attached hereto and incorporated herein; and

WHEREAS, following the filing of the Petition the Plan Commission scheduled a public hearing on the Petition for November 26, 2024; and

WHEREAS, at that public hearing the Plan Commission found that the Petitioner properly gave the necessary notice of the filing of the Petition and of the date and time of the public hearing thereon by publication in the manner prescribed by Ind. Code § 5-3-1-1 et. seq.; and

WHEREAS, the Plan Commission conducted the public hearing on the Petition and following said hearing, determined that the portions of the Property currently zoned R1A should be rezoned to Agricultural, all as permitted by the Joint Zoning Ordinance and Indiana law, and provided a favorable recommendation to the Board of Commissioners to rezone the portions of the Property currently zoned R1A to Agricultural.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of La Porte County, Indiana, pursuant to applicable laws, including Ind. Code § 36-7-4-608, that:

- 1. The Board of Commissioners find, based on all the evidence before it, that:
 - A. The requested change in zoning for the portions of the Property currently zoned R1A to Agricultural is compatible with the County's

comprehensive plan, the current conditions and the character of current structures and uses in each district; the most desirable uses for which the land in each district is adapted; the conservation of property values throughout the County; and responsible development and growth;

- B. The requested change in zoning will provide for the most reasonable use for which the Property is adapted and the proposed land use will not have an adverse effect on surrounding land;
- C. The requested change in zoning will not be injurious or detrimental to the surrounding property values and will further the conservation of property values throughout the County;
- D. The requested change in zoning will promote orderly and responsible community growth and development and will not adversely affect the community;
- E. The topography, soil condition, and other physical features of the land involved are suitable for the proposed use and zoning change;
- F. The change in zoning is not "spot zoning" which will confer a special benefit on a relatively small tract without commensurate benefit to the community; and
- G. The change in zoning will not disrupt or destroy any neighborhood plan.
- 2. The Board of Commissioners find that it is in the best interests of La Porte County and its residents that the Board of Commissioners accept and approve the recommendation of the Commission that the requested change in the County's zoning map be approved by the Board of Commissioners.
- 3. The zoning for the entirety of the Property, situated at 1655 North Shebel Road, Michigan City, IN 46360 in La Porte County, Parcel ID 46-05-27-300-002.000-046, legally described on Exhibit 1, shall be Agricultural and, as a result, the portions of the Property currently zoned R1A shall be changed to Agricultural; and the zoning map of La Porte County, Indiana shall be amended to reflect this change; and the amended zoning map shall hereafter be available in the County's Building Department for review and copying by the public.
- 4. The Clerk shall furnish a certified copy of this Ordinance to the County Recorder for recording and to the County Auditor.

5. This Ordinance shall be in effect from and after its passage according to law.
