MINUTES LA PORTE COUNTY COUNCIL REORGANIZATION MEETING JANUARY 6, 2025

The Reorganizational Meeting of the La Porte County Council was held on Monday, January 6, 2025 at 5:00 p.m. (local time) in the Assembly Room of the La Porte County Government Complex, 809 State St., La Porte, IN 46350.

The meeting will be called to order at 5:01 pm by Auditor Michael Rosenbaum, who asked everyone to silence their cell phones and stand for the Pledge of Allegiance and a moment of silence for former president, Jimmy Carter.

ROLL CALL

NOMINATION AND ELECTION OF 2025 LA PORTE COUNTY COUNCIL OFFICERS

Auditor Rosenbaum opened the floor for nominations for president of the Council. Brett Kessler nominated Adam Koronka and Randy Novak seconded the nomination. Hearing no additional names, a vocal vote was taken and was unanimous.

President Koronka then asked for nominations for Vice President of the Council. Justin Kiel nominated Brett Kessler and Randy Novak seconded the nomination. Hearing no additional names, a vocal vote was taken and was unanimous.
