#### **PUBLIC COMMENT**

Commissioner Steve Holifield addressed the council regarding significant budget cuts, suggesting that the council consider not filling positions due to retirements to save on salaries and benefits.

Marie Wiltfong and Gina Kloot, both long-term county employees, requested a review of the step increase policy, arguing that it unfairly affects employees who have dedicated many years to the county without receiving raises. They emphasized the need for recognition of their contributions and the potential impact on their retirement.

Tim Stabosz, former auditor, stepped to the podium to discuss several concerns. He also wondered why the auditor will not allow him access to the auditor's vault.

#### **DEPARTMENT HEAD REPORTS**

# Juvenile Services Center Update

Dion Campbell, the director for the Juvenile Services Center is currently serving 34 youth, with specific numbers in different programs, as reported. The center will host the Michigan City Youth Leadership Academy on June 12th, featuring Magistrate Stallworth and possibly Judge Havens. Additionally, it was acknowledged that team members will be graduating from the Purdue Northwest Leadership Institute.

#### LaPorte County Surveyor

John Matwyshyn, the county surveyor, approached the council to request funding for a cell phone and service, citing a lack of dedicated communication tools for his department. The total cost is estimated at \$1,000 for the phone and \$100 monthly for service, to be drawn from the perpetuation fund. Council members expressed concerns about ensuring proper communication with the commissioners and following the correct approval procedures.

#### Park Department

Details about an upcoming public input meeting for the Hunt Lake property on May 20th at New Prairie High School were shared by a conference room participant.

# **Emergency Repair Declaration and Discussion**

The emergency repair situation regarding the Hiler building was discussed, highlighting the necessity of immediate action due to sewage issues. Concerns were raised about the lack of competitive bidding for the emergency work, with Mr. Kiel suggesting the need for multiple preferred vendors in future situations.

#### **Economic Revitalization Area Proposal for Kingsbury Project**

The Kingsbury Biogas Project was discussed, which aims to establish an economic revitalization area in Kingsbury. The project involves an investment exceeding \$70 million and the creation of 11 full-time jobs, with a targeted timeline for construction from May 2025 to September 2026. The council is being asked to approve a personal property tax abatement for 10 years. A public hearing for Resolution 2025-3B was facilitated, which was approved after a motion by Mr. Novak and a second by Mr. Yagelski.

A motion to open the Public Hearing was made by Mr. Kiel and supported by Mr. Novak. A 7-0 vote was recorded to open the public hearing.
