# LAPORTE COUNTY COUNCIL REGULAR MEETING MINUTES JUNE 23, 2025

CALL TO ORDER The meeting was called to order by President Adam Koronka at 6:12 p.m.

PLEDGE OF ALLEGIANCE Councilman Mike Mollenhauer led the pledge.

**ROLL CALL** - Auditor Michael Rosenbaum called the roll and noted all members present.

**APPROVAL OF THE AGENDA** On a motion made by Councilman Yagelski and seconded by Councilman Kessler, the agenda was approved on a 7-0 vote.

**APPROVAL OF THE April 28<sup>th</sup> and May 28th, 2025 MEETING MINUTES** Councilman Novak made a motion to accept both the April 28<sup>th</sup> and Math 28<sup>th</sup> meeting minutes. Councilmen Kessler and Yagelski both seconded the motion. Motion passed on a 7-0 vote.

**PUBLIC COMMENT** Commissioner Steve Holified rose to speak on raises for the employees. He said the raises should be added to the budget this year.

#### **DEPARTMENT HEAD REPORTS**

Chief Probation Officer, Steve Eyrick asked for permission to purchase food not to exceed \$1,500 each for two meetings they are providing food for.

A motion to grant \$3,000 (\$1,500 each) was made by Councilman Yagelski and supported by Councilman Kessler.

Councilman Novak asked Mr. Eyrick if we are pursuing additional Opioid Grant funds.

Mr. Eyrick responded that Mickey Webb from the LaPorte County Drug Free Partnership was pursuing the grant.

Auditor Rosenbaum stated that the paperwork had to be submitted by Monday.

EMA director, Rob Sabie, spoke about an online meeting with Homeland Security Director, Kristie Nome.

FEMA is ending and will now be under the President. Right now, in the event of a disaster, the federal government provides 75% of the funding and local government provides the remaining 25%. They are looking to reverse that – the local government will pick up 75% and feds 25%.

New training will be available. It is not clear who will provide the training. A discussion took place on recent emergency.

•Commissioner Gramarossa approached the council about funding 58 sick days for an Adult Protective Services Employee who is retiring after 20 years service. APS is no longer being funded by the State, so the Commissioner was here asking for an additional appropriation. A discussion took place and it was decided that since this is a grant that is no longer in effect, the funding will need to come from the General Fund through an additional appropriation.

Councilman Yagelski made a motion and it was supported by Councilman Novak, that the sick days be paid by the Prosecutor from his alternate funds if possible, if not, it should be paid for from the general fund. It will be placed on next month's agenda under the Prosecutor.
